

WEBSITE PRIVACY POLICY

This policy outlines how we collect information from you, what we do with this information and why we collect it. Personal Data we Collect

We only collect data that helps us achieve the purpose set out in this Website Privacy Policy. We will not collect any additional data beyond the data listed below without notifying you first.

Data Collected Automatically

When you visit and use our Site, there is information about your computer hardware and software that is automatically collected and stored when you use our website. This information can include: your IP address, location, browser type, domain names, access times and referring website addresses.

Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site. This data may be collected when you use the 'Message Function' of our Site. The information collected includes your name, email address, and any other information such as phone number and address that you wish to include in the message.

Use of Collected Data

Data collected on our Site will only be used for the purpose specified within this Website Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond which we disclosed in this Website Privacy Policy.

We collect your personal data for the primary purpose of providing our services to you such as helping us improve your experience through our website. The data we collect when the user uses the 'Message Function' will be utilised to reply to the enquiry only. We may also use your personal data for secondary purposes closely related to the primary purpose, in circumstances where you would reasonably expect such use or disclosure.

Disclosure of Personal Data

We will not sell or share your data with other third parties, except in the following cases:

- If the law requires it;
- If it is required for any legal proceeding;
- To prove or protect our legal rights; and
- To buyers or potential buyers of this company in the event that we seek to sell the company.

We will not disclose your personal information to recipients in foreign countries without your written permission.

How Long we Store Personal Data

Users data will be stored until the purpose the data was collected for has been achieved.

We keep personal data only for as long as is reasonably necessary for the purpose for which it was collected or to comply with any applicable legal or ethical reporting or document retention requirements. Your Rights as a User

Cookie Policy

A cookie is a small file. Stored on a user's hard drive by a website. Its purpose is to collect data relating to the user's browsing habits.
